<u>Committee</u>	<u>Brief Description</u>
Alumni Services	<ul style="list-style-type: none"> - evaluate current methods of encouraging and maintaining alumni engagement in terms of interest, volunteering and giving; - recommend changes in programming, education, communications, etc., to improve alumni engagement
Graduate Retention	<ul style="list-style-type: none"> - evaluate current state of graduate retention vehicles at local, regional, and national levels; - recommend changes to improve graduate retention in terms of volunteering and giving
Chaplaincy	<ul style="list-style-type: none"> - this is the creation of a new type of chaplaincy offering to our brothers. The idea is to provide chaplain resources to each other in multiple disciplines (Christian, Jew, Muslim, Buddhist, Hindu, etc. - - for example: Christian minister; Jewish Rabbi; etc.) - the committee will recommend implementation of new policies and procedures and/or amendment of current policies and procedures to effectuate a more robust offering and use of chaplaincy services for and by the Fraternity
DEI&A	<ul style="list-style-type: none"> - evaluate current policies and methods utilized by the Fraternity to address DEI&A issues - recommend changes in programming, education, communications and/or other resources to improve our Fraternity's responsiveness to these issues
Financial	<ul style="list-style-type: none"> - evaluate on an ongoing basis the financial structure of the Fraternity and related entities; - provide counsel and recommendations regarding all financial issues - provide counsel to chapters when called upon
Governance	<ul style="list-style-type: none"> - evaluate, provide counsel, and make recommendations concerning all governance issues
Housing	<ul style="list-style-type: none"> - evaluate current national resources available to chapters relative to housing issues; - evaluate current content and methods of communication to chapters regarding available resources; - evaluate the state of current chapters' housing; - provide counsel to chapters regarding housing issues;



	<ul style="list-style-type: none"> - recommend the creation of and/or changes to local and/or national policies and procedures relative to local and/or national housing issues
Mental Health & Emotional Wellness	<ul style="list-style-type: none"> - evaluate current policies and procedures regarding mental health and emotional wellness issues; - recommend implementation of new policies and procedures and/or recommend changes to existing policies and procedures to improve our Fraternity's responsiveness to mental health and emotional wellness issues
Philanthropy & Service	<ul style="list-style-type: none"> - evaluate current national policies and procedures in area of philanthropy and service to others, including, but not limited to, the adequacy of our Fraternity's effort in SeriousFun philanthropy. - recommend change and/or implementation of policies and procedures to enhance Fraternity's effort in philanthropy and service
Health & Safety	<ul style="list-style-type: none"> - evaluate current national policies and procedures on health and safety risk management issues, including our Fraternity's emphasis, communication, and education of such issues to Resident Council membership - recommend changes and/or implementation of policies, procedures, communication, education

<u>Task Force</u>	<u>Brief Description</u>
Peer Analysis	<p>The idea here is to humbly acknowledge that there may be better ways of accomplishing goals than the way we're used to doing things. While the North American Interfraternity Conference has a wealth of information available as to what other groups are doing, our own Task Force will be equipped to evaluate such information (as well as other information) to determine whether it can help us. In that context, the Task Force would:</p> <ul style="list-style-type: none"> - conduct review of national fraternities and sororities to better evaluate effectiveness of Phi Kappa Tau in terms of finance, education, recruitment, governance, fundraising, housing, and other issues. - recommend implementation of new policies, procedures, structures, etc., and/or changes to existing structure to improve our Fraternity's current operations
Ritual	<ul style="list-style-type: none"> - evaluate the Fraternity's current ritual in terms of clarity, comprehensiveness, and confidentiality issues; - recommend needed amendments and/or additions
